CHSS 2018 SCHOLARSHIP & BURSARY APPLICATION PROCEDURE

The CHSS 2017 Scholarship & Bursary Booklet will be available online at <u>http://sd52.bc.ca/chss/</u> under "Grad info" by May 4, 2018. It is designed to present the financial awards made available by a number of Prince Rupert organizations and service clubs to graduating students who are planning to attend a post-secondary institution.

These organizations are to be **thanked** for their generosity and for their recognition of the real need that exists for all students who embark on further education.

The following page of this booklet provides some indication of costs that may be incurred at a post-secondary institution. These figures have been provided by your counsellor and are intended as a guide only. Check post-secondary websites for updated costs.

The financial awards described in this booklet have been divided into three categories, as follows:

- Awards:presented upon fulfilment of specific criteria as outlined in each
award description.
- Bursaries: presented on the basis of fulfilment of criteria and demonstrated financial need.
- Scholarships: presented on the basis of academic achievement or combined academic, athletic and citizenship achievements.

Students applying for bursaries must present proof of financial need (statement of need).

Students applying for scholarships must present a transcript of secondary grades as well as a short written description of their athletic and/or leadership qualities when these are specified in the scholarship applied for.

- 1) All students wanting to be considered for awards must fill out the application form with supporting documents and attach a list of awards for which they are applying.
- 2) Please make sure to set a time to see Ms. Offutt, Ms. Bryant in order to review and clarify all information on your application.
- 3) Deadline for application is May 4.2018.
- 4) Scholarship, bursary and award recipients will be determined by the Scholarships and Awards Committee or some organizations will choose their recipients and notify the school.

Bob Quast Memorial Award

The Bob Quast Memorial Award has been established to provide an award of \$750.00 annually to the successful candidate.

Criteria:

- 1) The candidate must be a graduate of Charles Hays Secondary School.
- 2) The candidate must have enrolled in a post-secondary institution and the award will be provided upon receipt of registration at a recognized university, college, technical school, or emergency services academy (firefighter, police, paramedic).
- 3) This award must be used within 24 months of graduation.
- 4) The candidate must have achieved a C+ or higher in every grade 11 & 12 course in which they were enrolled (candidates for this award are disqualified if they have dropped any grade 11 or 12 course more than halfway through its completion).
- 5) The candidate must be strongly dedicated to at least one extracurricular activity.
- 6) The candidate must possess an exemplary record with respect to attendance and punctuality.
- 7) The candidate must display excellent citizenship at the school and/or community level.

FILIPINO-CANADIAN ASSOCIATION OF PRINCE RUPERT

The Filipino Canadian Association of Prince Rupert will provide \$1000.00 in award money to a student or students (divided equally if more than one is eligible) graduating from Charles Hays Secondary School.

The following conditions must be met before this award may be granted:

- 1. Preference will be given to the son, daughter, or dependent of a member in good standing and active in the association and with the residency of three consecutive years.
- 2. The candidate/candidates must have enrolled in a post-secondary institution and submit a copy of the registration and receipt of tuition to the Association within a year.
- 3. The school officials will recommend students and the Board of Directors of the Association will decide on the recipient/recipients based on the pre-set criteria.

To whom it may concern;

Salut. AFFNO is proud to be offering a bursary of \$500 to an eligible French Immersion Grade 12 student, or (if applicable), a Grade 12 Francophone student that is enrolled and graduating from the CSF Francophone online program (in conjunction with the students' other classes at Caledonia). Our criteria is as follows:

1) The graduating high school student must have completed French Immersion 12 (this year – 2017-2018) and/or the CSF Francophone Grade 12 online program.

2) The student wishing to be a recipient of this bursary must write a letter IN FRENCH to AFFNO (approx. 200 to 400 words), outlining the following:

a) What staying in French Immersion and/or the CSF Francophone program right through Grade 12 meant to them (i.e. why they chose to stay in the program, the impact it has had on their lives, their future, etc.);

- b) What they plan to do with French language in their future;
- c) What they would use the bursary for.

3) The letter must be received by AFFNO by May 11, 2018, either via Canada Post (address above), or via email to: <u>affno@citywest.ca</u>. (If email, please paste letter directly in the email NO ATTACHMENTS!) A hand-written letter will be accepted, as long as it is legible.

4) The bursary must be used within 18 months, meaning the student could choose to use it in September 2018, January 2019, September 2019, or January 2020. Bursary expires as of February, 2020. Proof of transcript also required before cheque will be released.

LUCAS ANDERS LEGACY AWARD

The Lucas Anders Legacy Award is presented to commemorate the work and volunteerism of former Prince Rupert radio host Lucas Anders, who from 2014 to 2016 worked in the city as a morning disc jockey and occasional teacher-on-call with School District 52. As well, he performed with Harbour Theatre Society (founding an improvisational comedy troupe), participated in curling and hockey leagues, and sharpened his public speaking skills as a member of the Prince Rupert Toastmasters Club.

Following his departure from Prince Rupert, a friend and frequent collaborator created this award to benefit high school graduates with a similar commitment to community-enriching volunteer activity — and the intent to follow Lucas into the field of broadcasting.

During his teacher-on-call assignments, Lucas inspired students at local elementary schools, Prince Rupert Middle School, and Charles Hays Secondary School. Therefore this award will be offered for twelve years (2017 to 2028 inclusive), until the last Prince Rupert and Port Edward students who knew "Mr. Anders" have graduated.

The Lucas Anders Legacy Award constitutes \$500 in award money presented to a student graduating from Charles Hays Secondary School.

Criteria:

- 1. The candidate must be a graduate of Charles Hays Secondary School.
- 2. The candidate must intend to enrol in a post-secondary institution. Candidates must present proof of their application to a television, radio or other specialized broadcasting program at a recognized university, college or technical school in which they will enrol before 18 months elapse.

If there are no suitable candidates pursuing post-secondary broadcast training, then graduates applying to the Faculty of Education at a recognized university or college are also eligible for this award, with the 18-month deadline for enrolment similarly applicable.

- 3. The candidate must display excellent citizenship at the school and/or community level.
- 4. The candidate must be strongly dedicated to at least one extracurricular activity.
- 5. A 500-word essay or five-minute (maximum) multimedia work is required, on the subject of how media can enrich communities.

Selection Process:

Eligible students may apply for this award by submitting (i) proof of application to a qualifying post-secondary institution and (ii) the requisite essay or multimedia work to school officials. Submissions must be received no later than April 30th.

School officials will provide the applications — with their recommendations based on the criteria above — to the award sponsor.

The award sponsor will select a candidate, considering applicants' merit and recommendations from school officials, in consultation with Lucas Anders himself.

Disbursement Process:

The award will be presented to the selected candidate upon submission to school officials of proof of enrolment at a relevant post-secondary institution. This may occur any time in the 18 months following the candidate's selection as recipient of the Lucas Anders Legacy Award.

Note on Publicity:

The award sponsor reserves the right to publish any applicant's essay or multimedia work in the service of publicizing the Lucas Anders Legacy Award.

MAKING HEALTHY CHOICES - AWARDS for DRUG-FREE YOUTH

Community Prevention Education Continuum (CPEC) and the Prince Rupert Sikh Missionary Society have joined to provide \$1000 in award money to two Grade 12 graduating students (\$500 each) in the Prince Rupert area who have made the decision to be drug, tobacco and alcohol free during their high school years. CPEC is designed as a sustainable community-lead, police assisted, comprehensive youth drug prevention strategy (da.bc.rcmp.ca). The smart and healthy choice to avoid the use of illegal substances, focus on academics and healthy school and community activities is a choice worthy of commendation. To be eligible for these awards, students must meet the following criteria:

- 1. Have not used alcohol, tobacco or illegal drugs during their lifetime;
- 2. Write a one page essay (type written and double spaced) that describes specifically how you have lived and modeled a drug free life; why you made the choice to be alcohol and drug free; and what role youth can play in drug free prevention efforts;
- 3. List in detail specific drug prevention activities you have been involved in and list your extracurricular activities both in school and in your community;
- 4. Complete the general application included in this awards booklet which specifies Post-secondary schools you have applied to, program of study, and current contact information for you and your parents/guardians;
- Include three references (one is a parent/guardian) who can affirm your drug free lifestyle and Healthy choices as stated on your declaration of being drug free. (Statement of Support on page 8);
- 6. Provide proof of registration in a post-secondary school, have 30 days of full time attendance at a post-secondary school, and a tuition receipt before the award money will be disbursed;
- 7. A member of a community organization and/or an RCMP member may be involved in the selection of the recipients.

THE ROGER OBATA ACHIEVEMENT AWARD (2005 - 2016)

The Friends of Roger Obata Committee (Toronto, Ontario), is pleased to sponsor one award of \$1000.00, to be given for the next ten years to one CHSS graduating student. Mr. Obata, a successful businessman, received a degree in engineering from the University of British Columbia, and served with the Canadian Army during the Second World War. He is known for his outstanding contributions to the Japanese Canadian community over a period of 50 years, especially in the area of human rights. He was a valued member of the strategy team that signed the historic Redress Agreement with the Government of Canada in 1988.

Mr. Obata was named to the Order of Canada in 1990 for his human rights activities, and was an example for all Canadians who love justice and freedom. He died in Toronto in 2002.
